### About Defentect

Committed to creating a critical part of the protection network against terrorism, Defentect develops and markets intelligent threat awareness and radiation detection systems customized for clients. Defentect is a homeland and physical security technology firm providing detection, messaging and alert systems that monitor threat level radioactive materials used in the manufacture of dirty bombs and other terrorist devices.

Its flagship product, Defentect DM3™, is the management, monitoring and messaging software that integrates data from broadly deployed gamma radiation sensors to an incident command center. Defentect's DM3™ is networked using IP and managed over the Web. When high-energy gamma rays from dirty bomb components interact with Defentect's Gammatect™ sensors, DM3's™ proprietary algorithms analyze the data and alert authorities to radiation that may pose a security threat. Communication features of DM3™ provide the ability to receive and process data over a network from the radiation sensor to the command center as well to PDAs, cellphones or pagers. The addition of strategically placed Gammatect Plus™ sensors enables DM3™ to identify the isotope causing the radiation, providing control over false positive alarms.

Defentect's DM3™ software is the management, monitoring and messaging component that provides administrative and configuration services for the detection system. Devices can be configured, status can be monitored, alert messages can be sent to a variety of systems, system reports can be generated and multiple user accounts can be set with various privileges. The Defentect intelligent threat awareness network offers integrated, unattended detection, alerts and messaging for a variety of threat-event demands including chemical, biological, nuclear, explosive and other threat events.

### Defentect's Value Proposition

Currently, it is impractical and labor-intensive to detect hazardous radiation in large public facilities and sites storing radioactive source material. The Department of Homeland Security believes key facilities will be the likely targets of terrorist attacks and is investing in detection technologies. Existing radiation detection systems are either hand-held or portal installations requiring specialized equipment and costly human involvement. Proposed new sensor technology requires installation of specialized equipment requiring higher cost and deployment time than Defentect's DM3™. Defentect offers a large incremental benefit to its customers for the relatively small cost of adding radiation detection capability to a new or existing surveillance network.
